Thanks Alex.

This is exactly what I was referring to. Out of the 174 'Loss of Eligibility' offers that you provided, 164 has a coverage start date of 1/1/2017 and a different event date (a date later in the year).

But I'm assuming that all of these might not be the second or third offers. This list might also show the 'loss of eligibility' offers as the only offers sent for few employees in the file. So we need to exclude those too.

Would it be possible for you to pull the list of term offers that are sent as a second or third (but not as a first offer)?

Maybe that would help us filter down to the exact number....which I'm still thinking will be more than what was provided in the discrepancy report by ADP.

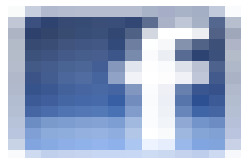
